#### New study on Female Genital Mutilation

EIGE launched, following a call from the European Commission, a study to estimate the number of women and girls at risk of Female Genital Mutilation (FGM) in selected EU Member States.

The study is very challenging: it wants to propose a methodology for all Member States to support policy-making on combating FGM.

The study will have four main stages:

- 1. Mapping the legal and policy frameworks and the efforts to quantify FGM in all Member States;
- 2. **Identifying and reviewing** existing studies on FGM risk estimation in order to define the best methodological approach;
- 3. Running **pilot studies** in three Member States in order to estimate the number of girls at risk;
- 4. Development of **methodological recommendations** for risk estimation of FGM in all EU Member States.

The data collection for the study will be finished at the end of 2014. The recommendations are expected by May 2015. More information

### Extensive study on administrative data sources on gender-based violence



"Mapping administrative data sources on gender-based violence against women in the EU-28" is a study EIGE has worked on since 2013. It aimed to gain a comparable overview of the extent, nature and consequences of gender-based violence across the EU-28.

Administrative data reflect what is recorded by an agency dealing with a victim or perpetrator of gender-based violence. The data can provide detailed information on how police, judicial, health and social services respond to the prevention, protection and prosecution of gender-based violence across the EU. The results of the study have been presented in a splendid on line tool.

# Peer Review: Good practices in promoting women's entrepreneurship

On 19th and 20th June 2014 at EIGE in Vilnius three excellent good practices on women's entrepreneurship chosen at the Athens meeting were presented:

- Going for Growth, Ireland (training)
- Women's Cooperative Bank, Cyprus (funding)
- Navigation towards Independence (Gründerinnenzentrale), Germany (networking)



EIGE's work on the benefits of gender equality in the area of entrepreneurship was also presented and discussed. The 30 experts from the EU Member states at the Peer Review meeting agreed on a set of policy related and methodological

recommendations. The recommendations tell us how to promote and support women's economic independence and economic empowerment through entrepreneurship.

### Consultation: good practices on reconciliation

Within EIGE's work in the area of gender mainstreaming a consultation meeting in the area of reconciliation was held in Vilnius 22nd and 23rd May 2014. After introducing the main trends, experts from the EU Member States discussed the

selected13 good practices to be further disseminated and promoted.

The 13 good practices, from 9 Member States, relate to awareness-raising, benchmarking and self-regulation.
