It will improve the history of the work with one and the same child in risk. This is necessary because sometimes the staff changes in child protection departments or the family of the child moves and another child protection department continue to deal with the case. This will improve the statistics about children in risk on one hand, but also the effect of the social work effect on the other hand.
