Gender Equality Index 2017: Ireland

The Gender Equality Index 2017 examines the progress and challenges in achieving gender equality across the European Union from 2005 to 2015. Using a scale from 1 (full inequality) to 100 (full equality), it measures the differences between women and men in key domains of the EU policy framework (work, money, knowledge, time, power and health). The Index also measures violence against women and intersecting inequalities. These are satellite domains and are part of the framework of the Gender Equality Index, but do not have an impact on the overall score. Intersecting inequalities show how gender intersects with age, education, family composition, country of birth and disability. The Gender Equality Index provides results for each domain and sub-domain for the EU and its 28 Member States (1).

Progress in gender equality in Ireland, 2005-2015

In the Gender Equality Index 2017 Ireland achieved a score of **66.5 out of 100**. This is an increase of 70 points since 2005, which shows better progress than all EU level Ireland's score three points ahead of the EU average (from 2005 to 2015, Ireland's score went up by 70 to eight out of 10 domains score have increased with the exception of the domain of time which saw no improvement).

The domain of **power** shows significant improvements due to progress in equality, employment and representation in the workplace as well as Women's representation in political decision-making, also improved labour force inequality.

The domain of **knowledge** shows solid progress in educational attainment and participation for both women and men. However, strong segregation of study fields along traditional gender lines remains a challenge. Inequality also persists in the domain of **time**, especially when it comes to social activities.

The situation in the domain of **work** has slightly improved due to a combination of women's and men's increased participation in the labour market, low segregation and high quality of work.

In the domain of **money**, more progress is evident, namely in the more equal income distribution and decreasing gender gaps in savings and income.

The gender equality score in the domain of **health** is high, showing good gender balance in access to services and overall health status. However, there are important differences in the health-care behaviour of women and men.

(1) The Gender Equality Index 2017 is based on the data of Gender Equality Index, EU Gender Index Survey, European Health Interview Survey, EU Survey on Income and Living Conditions, Structure of Europe Survey of Knowledge (European Quality of Life Survey), European Working Conditions Survey, EU Gender Equality Index (Women and Men in Decision-making) and EU Gender Equality Index (Violence Against Women Survey).
