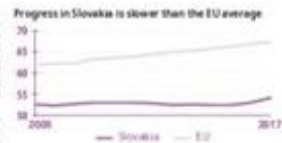


# Gender Equality Index 2019: Slovakia



With **54.1 out of 100 points**, Slovakia ranks 26th in the EU on the Gender Equality Index. Its score is 13.3 points lower than the EU's score. Between 2005 and 2017, Slovakia's score increased by only 1.6 points (+ 1.7 points since 2015). Slovakia is progressing towards gender equality at a much slower pace than other EU Member States. Its ranking has dropped seven places since 2005.

Slovakia's scores are lower than the EU's scores in all domains. Gender inequalities are most pronounced in the domain of power (26.8 points) and time (46.3 points). Slovakia achieves its highest score in the domain of health (85.8 points), which is also closest to the EU score. Since 2005, Slovakia's scores have improved the most in the domain of money (+ 12.7 points) and knowledge (+ 5.9). Progress has stalled in the domain of power (- 0.1 points) and Slovakia's score decreased in the domain of time (- 9 points). Between 2005 and 2017, Slovakia improved its Index score but had much lower score than the EU during the entire period. Slovakia also moved towards gender equality at a slower rate, increasing the gap with the EU's score over time.



Each year we score EU Member States and the EU as a whole to see how far they are from reaching gender equality. The Index uses a scale of 1 to 100, where 1 is for total inequality and 100 is for total equality. The scores are based on the gaps between women and men and levels of achievement in six core domains: work, money, knowledge, time, power and health. Two additional domains are integrated into the Index but do not have an impact on the final score. The domain of intersecting inequalities highlights how gender inequalities manifest in combination with age, disability, country of birth, education and family type. The domain of violence against women measures and analyses women's experiences of violence. In addition to providing a snapshot into the Index scores, the Gender Equality Index 2019 includes a thematic focus on work-life balance.
