

Gender Equality Index 2020 **CYPRUS**



Progress on gender equality in Cyprus since 2010

With 56.9 out of 100 points, Cyprus ranks 21st in the EU on the Gender Equality Index. Its score is 11 points lower than the EU's score.

Since 2010, Cyprus's score has increased by 7.9 points (+ 0.6 points since 2017). Making slightly faster progress towards gender equality than other Member States, Cyprus has improved its position by six places.



Best performance

Cyprus's highest scores are in the domains of health (88.0 points) and money (81.7 points), in which it also performs best in comparison with other Member States (ranking 13th for both).

Most room for improvement

Gender inequalities are most pronounced in the domain of power (29.8 points), where Cyprus also performs worst in comparison with other Member States (ranking 24th).

Biggest improvement

Since 2010, Cyprus's scores have improved in all domains. The biggest improvements are in the domains of power (+ 14.4 points) and time (+ 5.4 points).

Least progress

Cyprus has made the least progress in the domains of work (+ 0.3 points), knowledge (+ 0.7 points) and money (+ 1 point).

About the Index

Each year, we score the EU Member States and the EU as a whole to see how far they are from reaching gender equality. The Index uses a scale of 1 to 100, where 1 is for total inequality and 100 is for total equality.

The scores are based on the gaps between women and men and levels of achievement in six core domains – work, money, knowledge, time, power and health – and **their subdomains**. **Two additional domains** are included in the Index but do not have an impact on the final score. The domain of intersecting inequalities highlights how gender inequalities manifest in combination with age, (dis)ability, country of birth, education and family type. The domain of violence against women measures and analyses women's experiences of violence. The Index is composed of **31 indicators**. The Gender Equality Index 2020 also includes **a thematic focus on digitalisation and the future of work**.

Key highlights

Improvements in economic decisionmaking

The shares of women on the board of the central bank and on the boards of the largest publicly listed companies have increased.





Tertiary educational attainment is increasing among both women and men.




Improved access to medical


Unmet needs for medical care have decreased for women and men.


Improvements stagnate in political decision-making

Uneven concentration of women and men in education is a persistent problem


More women than men are studying education, health and welfare, or humanities and the arts.

Why is there no score for the violence domain?

There is no new data to update the score for violence, which is why it no figure is given. Eurostat is currently coordinating an EU-wide survey on gender-based violence, with results expected in 2023. EIGE will launch a second round of administrative data collection on intimate partner violence, rape and femicide in 2022. Both data sources will be used to update the domain of violence in the Gender Equality Index 2024.

Unlike the other domains of the Index, the domain of violence does not measure differences between women's and men's situations; rather, it examines women's experiences of violence (prevalence, severity and disclosure). The overall objective is not to reduce the gaps in violence between women and men, but to eradicate violence completely.

Data gaps mask the true scale of violence.

The EU needs comprehensive, up-to-date and comparable data to develop effective policies that combat violence against women.


Female Genital Mutilation (FGM)

During the COVID-19 lockdowns, women in violent relationships were stuck at home and exposed to their abuser for long periods of time, putting them at greater risk of domestic violence. Even without a pandemic, women face the greatest danger from people they know.

Istanbul Convention: state of play

The Istanbul Convention is the most comprehensive international human rights treaty on violence against women and domestic violence. Cyprus signed the Convention in June 2015 and ratified it in November 2017. The treaty entered into force in March 2018.




Thematic focus on digitalisation and the future of work

The Gender Equality Index 2020 focuses on digitalisation and the future of work. The thematic focus looks at three areas:


- use and development of digital skills and technologies;


