# Gender impact assessment as part of the regulatory impact assessment initiative

- ▶ AGE during 2019, continued with delivering the 10 capacity development activities regarding the gender impact assessment, with focus on members of working groups, where employees of ministries, who work directly in drafting concept documents of the forthcoming new legislations from various sectors . In total 280 members of working groups were trained during 2019 , with the support project of Sida for AGE “Niras & CPM International”.
- ▶ Manual for the practicing the “Gender impact assessment” is drafted and is in the process of publication ,through which we aim to measure the impact of possible public policy interventions and legislation, assessing positive or negative impact on lives of men and women, as well as certain social segments .

# Combating gender stereotypes

- ▶ **AGE continues to build the capacities of Public Information Officials and Private Media Companies in order to increase gender sensitivity in presenting the pro-gender agenda of institutions as well as presenting and picturing women in media and advertising. Media training on adequate pro-gender presentation was organized through the SIDA's support project and was attended by 30 participants**

# Combating gender stereotypes

- ▶ AGE in the process of MEST reviewing textbooks, with aim to fight gender stereotypes and mainstreaming gender perspective drafted the Manual **“Preventing Gender Stereotypes and Promoting Gender equality in Schol Textbooks and Materials”** . The manual aims to provide concrete guidelines for text writers, reviewers, and teachers themselves on how to mainstream the gender perspective, to challenge the overburdened gender relations with stereotyped gender roles.

# AGE & Faculty of Economics

- **The Faculty of Economics has rewired the curriculum and will start the implementation of the new subject “Gender Economics”. AGE supported the faculty with international expertise in gender in economics**
- **Curriculum approved, two workshops, text books for the faculty will be provided by AGE**
- **Financed by the SIDA**

# Gender mainstreaming

- **During the 2019 AGE has delivered comments for integration of gender perspective in: 18 draft regulations, 7 concept documents , 10 draft laws, 11 draft administrative instruction and in 1 strategic document**
