Kosovo component-

Result 3.2 Improved case management by providers of specialist support services for victims of all forms of violence, with a specific focus on women and girls from minorities and disadvantaged groups

- The contract with implementing partner has been signed in December 2017
- The IT company -subcontracted by the IP to support the establishment of the DB
- DB was launched in April 2019, with the signing of an MOU between the Ministry of Justice, Ministry of Labor and Social Welfare, Kosovo Judicial Council, Kosovo Prosecutorial Council and Kosovo Police Integrated Database on Cases of DV:
- Manual developed for DB users, training provided in all regions of Kosovo (including Police, Center for social Work , Prosecutors, Judges, Shelters) – more than 120 service providers trained


Other info:

- The DB is located at the Ministry of Justice
- It includes data disaggregated by sex, age, marital status, employment status, economic situation , nationality
- IT Assistant supported by the Program (and Justice 2020 program) located at the MoJ
- It is a living tool- it is updated and needs to be advanced
