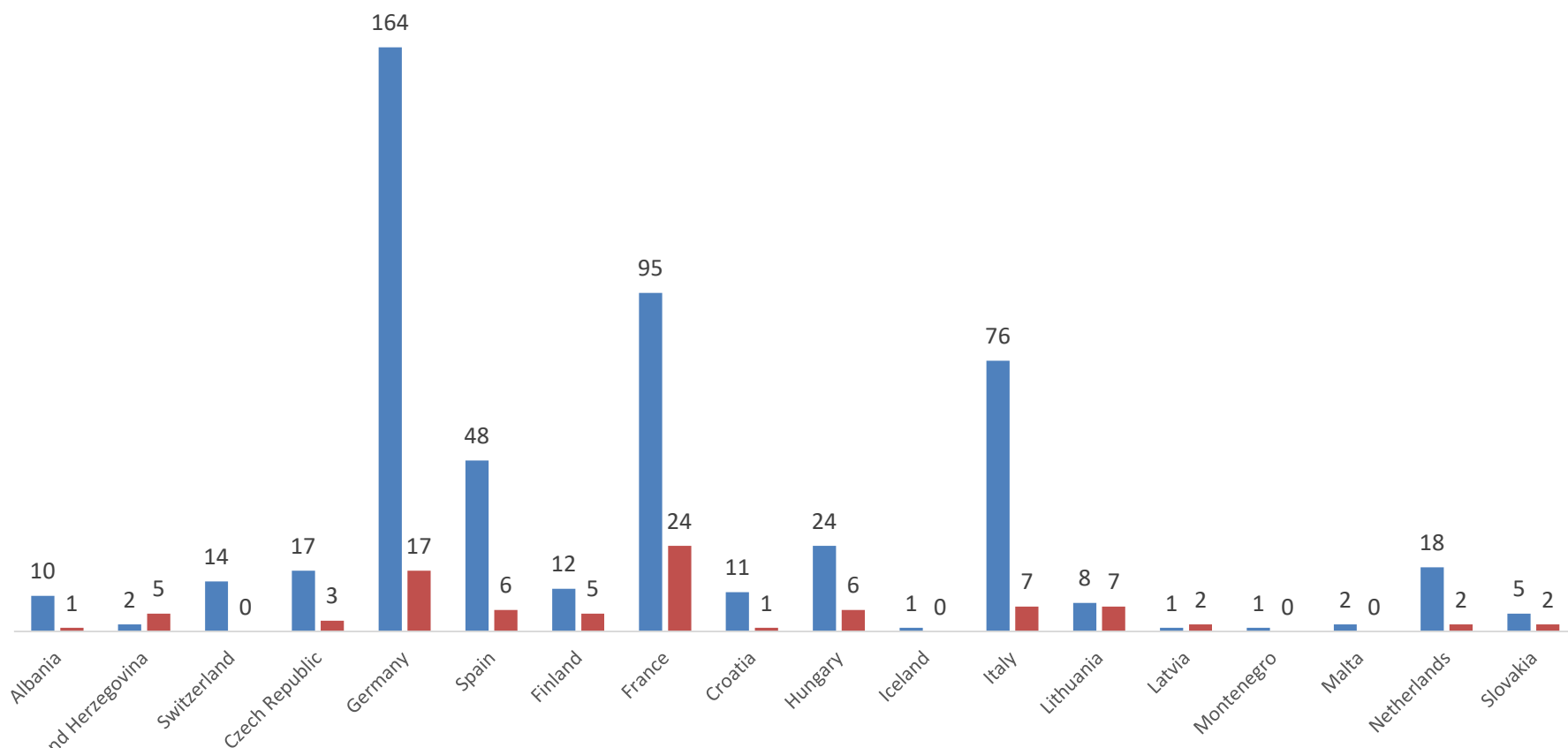

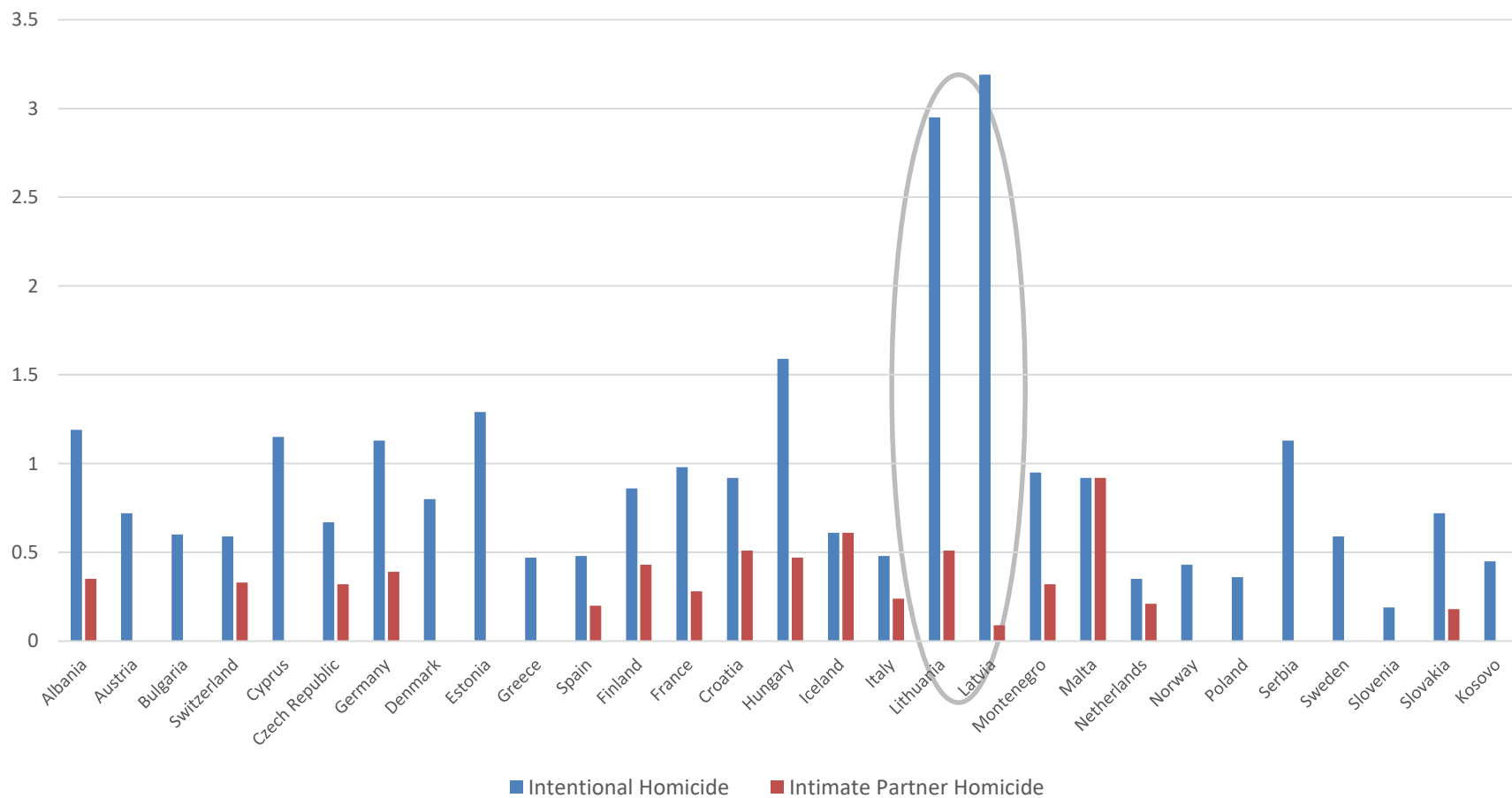

NUMBER OF MEN AND WOMEN KILLED BY THEIR INTIMATE PARTNER

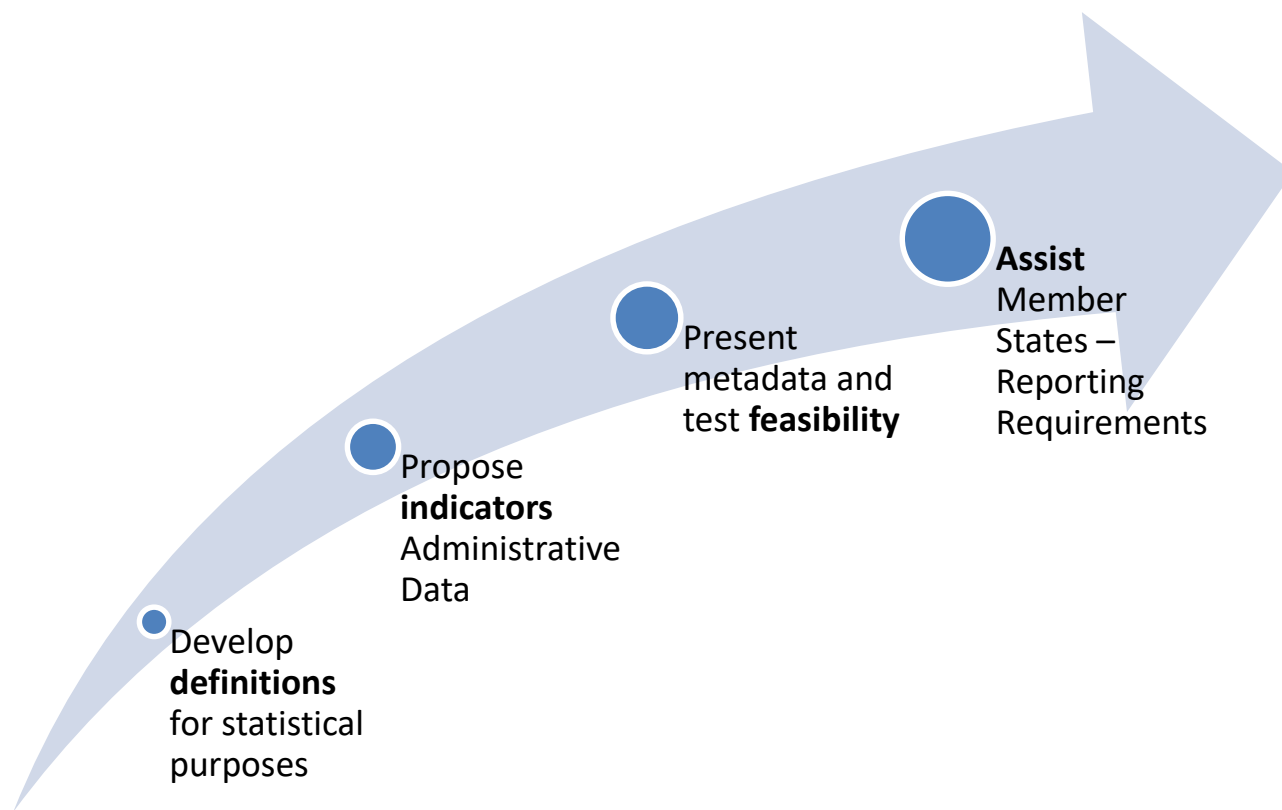


What we know?

Women killed in 2016 per hundred thousand inhabitants

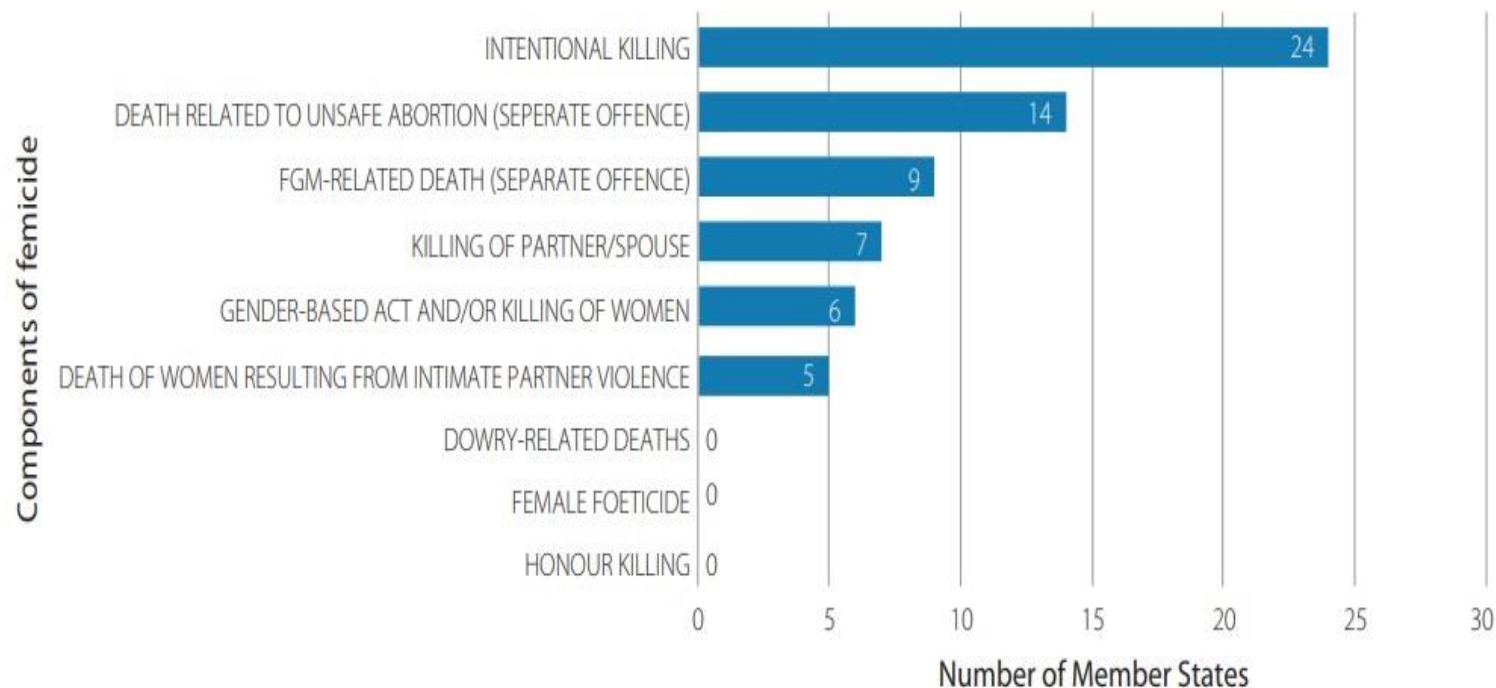

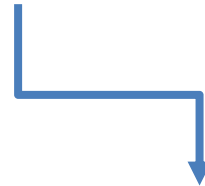
Components of femicide in Member States



Uniform definition & Indicator

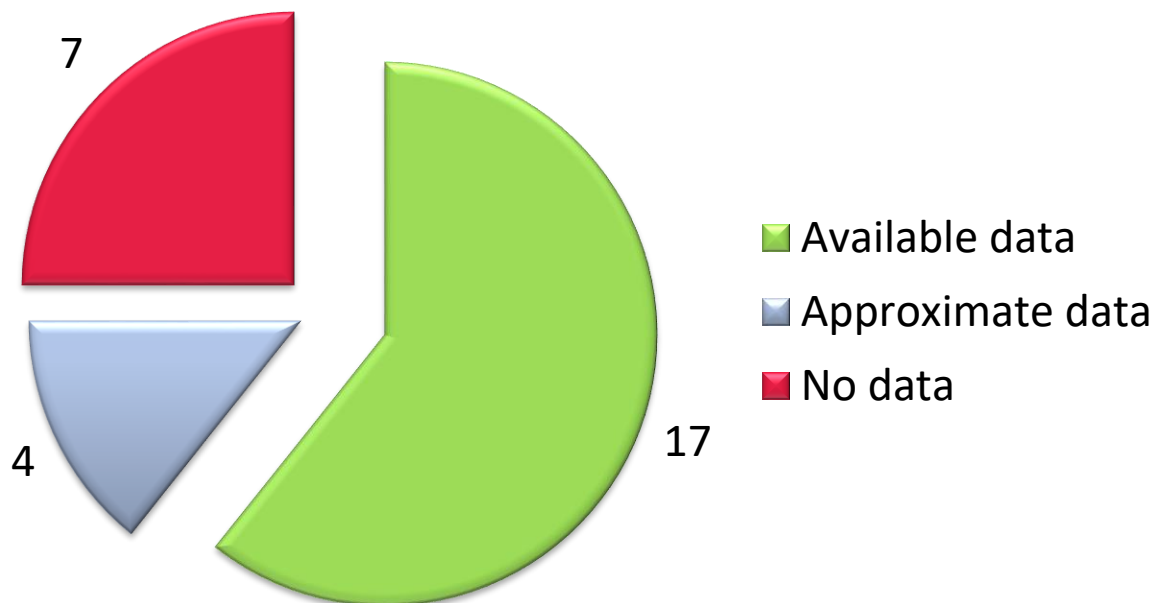
The killing of a woman by an intimate partner and the death of a woman as a result of a practice that is harmful to women.

Intimate partner is understood as a former or current spouse or partner, whether or not the perpetrator shares or has shared the same residence with the victim.



Women victims of intimate femicide aged 18 and over committed by an intimate partner, as a share of women victims of homicide aged 18 and over

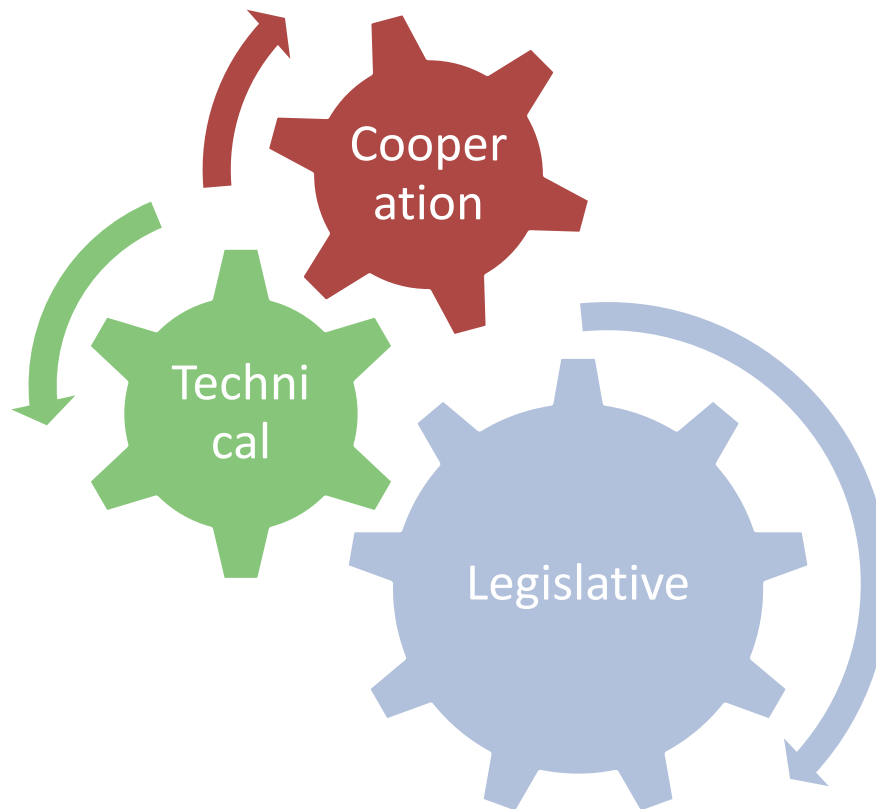
