Field of work – **AWEN**: A network of Albanian women's rights organizations, formed in 2008. AWEN works with strengthening women in Albania socially, economically, culturally and politically. AWEN is focused on advocacy at local and national levels, for issues related to protection and promotion of women rights. Field of work – **AWSP**: The Association was established in 1999, when the Kosovo refugees came to Albania for getting emergency support. Over a decade, it has been providing various services to vulnerable women of the Durres Region, consisting of psycho- social, legal, and medical services, as well as on the provision of informative and awareness activities. Concrete lobbying and advocacy initiatives with regard to the community development, with a specific focus on the strengthening of women status in society, has also been an important AWSP area.

Field of work: Vatra is a non-profit organisation, a psychosocial center, formed in 1999. It focuses on prevention and raising awareness of human trafficking and domestic violence, direct assistance to victims of human trafficking and victims of domestic violence and their children, capacity building for state and non-state institutions related to trafficking and gender-based violence issues, lobbying and advocacy. In 2001, Vatra established the first shelter in Albania for

CWR has launched numerous initiatives aimed at enhancing human rights (particularly women's human rights), including the initiative for equal treatment of marital and extra-marital partners in achieving the right to family pension. Country: Serbia Organisation: ASTRA – Anti Trafficking Action, Belgrade

Field of work: Astra is a Belgrade-based organisation established in 2000 as the first actor to raise the issue of human trafficking in Serbia. ASTRA applies a comprehensive approach to the human trafficking problem, i.e. deals with all forms of human trafficking and all categories of survivors – women, children and men, focusing its activities concurrently on prevention, education, public awareness raising, direct victim assistance and reintegration, research and networking. Since 2002, ASTRA has been running an SOS hotline for victims of trafficking, still the only one in Serbia. It has developed a network of 30 specialised lawyers, as well as a network of 20 psychotherapists trained to work with trafficking trauma. In 2007, ASTRA opened a daily center, primarily for victims who do not live in shelters. It has also built and provided training to the Serbian anti-trafficking network. ASTRA is a member of the world-wide anti trafficking GAATW network and European anti-trafficking NGO platform. Field of work: Autonomous Women's Centre (AWC) was founded in 1993 with the aim to organise support for women survivors of male violence. In the first six years, the work was mainly focused on providing support to women refugees, women raped during the war and women survivors of any type of violence. After the turnover of the Milosevic's regime in 2000, the AWC started to work on lobbying the government and the state for laws, protocols and standards in the field of



violence against women. The main goal of AWC is to advocate women's human rights and gender equality in order to prevent/decrease the violence against women and strengthen the democratic society. AWC is now a member of a coalition of NGOs in Serbia called prEUgovor ("PreNup"), that participates in EU accession processes, writes reports and builds its own capacities to be an equal partner during the process. **Site:** <u>https://www.womenngo.org.rs/en/</u>
