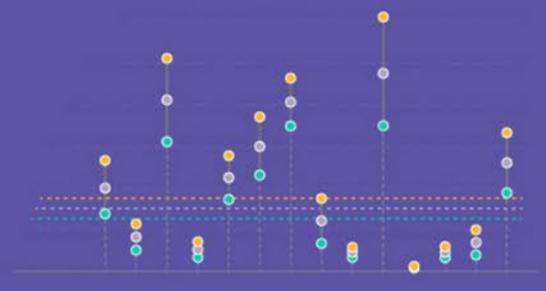

Developed by EIGE, the Gender Equality Index measures how far (or close) the EU and its Member States are from achieving gender equality.

EIGE's Gender Statistics Database presents all data under six **core domains** (work, money, knowledge, time, power and health) and **two additional domains** (intersectionalities and violence).

From 2019, data updated every year

EIGE collects data on the share of women and men in key decision-making positions in different policy areas.

The Database provides information that can be used to monitor progress towards the achievement of gender equality in decision-making. Data on decision-making is collected for:

- EU Member States
- Five EU candidates: Montenegro, North Macedonia, Albania, Serbia and Turkey
- Two potential candidates: Bosnia and Herzegovina and Kosovo\*
- Three EEA countries —Iceland, Liechtenstein and Norway

\* This designation is without prejudice to positions on status, and is in line with UNSCR 1244/1999 and the ICJ Opinion on the Kosovo declaration of independence.

Data on Politics is updated every quarter. Data on Business and finance twice per year.

The Gender Statistics Database contains data on gender-based violence from administrative and survey data sources.

The database provides access to existing statistical data on gender-based violence, to support institutions and experts engaged in preventing and combating gender-based violence in the European Union and beyond.

## How to search in the Database?

Users can either browse the Database using a set of predefined entry points covering gender-relevant topics, or look for data using a keyword search.

The **browsing option** is geared toward users who want to explore a category of statistical indicators (e.g. general thematic areas or specific themes such as decision-making). It is also user-friendly, and gives a structured guide to the available data. **The browsing structure is organised into entry points.** The entry points and tree structure are adapted regularly to suit users' needs.

The **keyword search option** is most suited to those who are looking for a specific dataset or area of interest but are not sure where to find it in the predefined structures.

## Do you have data? These are the quality criteria

EIGE has adopted the quality assessment and assurance framework of the [European Statistical System](#) to evaluate data quality.

Data quality is assessed against the quality evaluation principles outlined in the [European Statistics Code of Practice](#).

## How to explore different data visualisations?

EIGE's Gender Statistics Database displays statistical data in three different ways:



### EU Heat Map

Displays data using heat and symbol maps

The **EU Heat Map** is an interactive map viewer. For each selected indicator, the map displays the countries with different colour intensities; the higher the value of the indicator, the lower the colour intensity shown on the map.



### Vertical or horizontal bar chart

Presents data for women and men at the country and EU levels, for one year at a time.

A bar **chart** shows data using bars that are proportional to the data values. Horizontal bar charts present the data values on the horizontal axis and the countries on the vertical axis. Vertical bar charts present all available countries on the horizontal axis and the data values on the vertical axis.



### Line chart

Compares data over time, against other countries or the EU average

A **line chart** is a graphic representation of data that is plotted using a series of lines. Each line represents a country, and uses a different colour for each one. In this way, countries can be presented one at a time, in batches or against the EU average. All available years are on the horizontal axis and the data values on the vertical axis.



### Data table

Displays existing data in a table

Data can also be visualised in a simple table. The table visualisation allows you to filter the data for selected years, countries and gender. For indicators that are not fully comparable across countries, e.g. those on gender-based violence, the data table is the only visualisation available.

## How to download tables and graphs?



### Export

All tables, charts and maps can be exported in different formats using the export button.

You can export data tables and visualisations in multiple formats. All visualisations (EU Heat Map, bar chart, line chart) can be exported and downloaded in PNG or JPG files.

Data tables can be exported and downloaded in **CSV, XLS, XML and JSON** files. Graphs and maps can be saved as **JPG, PNG, IFRAME** formats.
