### EIGE's new study focuses on poverty in Europe

Over half of the 122 million people at risk of poverty and social exclusion in Europe are women. EIGE has started to work on a report addressing the links between gender and other inequalities. It will focus on the reality faced by lone parents, migrants, young and elderly women and Roma population living in poverty. The report will be published by the end of 2016. [Read more.](#)
